APPROVAL OF MAP 18692 FOR WATER APPROPRIATION A-19106

WATER DIVISION 1-C

BACKGROUND

1. On July 15, 2013, Philip and Diana L. Wehrman filed in the Department of Natural Resources (Department) application A-19106 for a Permit to Appropriate Water.
2. On October 16, 2013, Philip Wehrman filed in the Department map number 18692 showing land proposed to be irrigated under application A-19106.

ORDER

IT IS HEREBY ORDERED:

1. Map number 18692 is APPROVED.
2. The following is a description of all the land which is authorized to be irrigated (appurtenant land) under surface water appropriation A-19106 as depicted on map number 18692:

3. Appropriation A-19106 authorizes the appropriator the use of 181.5 acre-feet annually from Wehrman Reservoir (storage appropriation A-12256 and supplemental storage appropriation A-19107) from a pump site located in the E $\frac{1}{2}$ NE $\frac{1}{4}$ of Section 28, Township 3 North, Range 7 West of the 6th P.M. in Nuckolls County.

4. Appropriation A-19106 provides supplemental water to irrigate land under surface water appropriations A-12180 and A-19105.
5. The appropriator is bound by all terms and conditions of the approval of application A-19106.
